The Wisconsin Council on Forestry is appreciative of the opportunity to discuss forestry related budgetary items important to Wisconsin's forestry community with you and your staff on August 11th.

Appointed by the Governor, the Wisconsin Council on Forestry is a diverse group of leaders in the forestry community who direct Wisconsin's efforts to achieve sustainable forestry. The Council was created by State Statute in 2002 to advise the governor, legislature, Department of Natural Resources, Department of Commerce, and other state agencies on a host of forestry issues. The Council has routinely weighed in with the administration and legislators during past biennial budget efforts.

Forests in Wisconsin are one of our most powerful economic drivers and one of our best environmental assets. Funding for forestry programs is an investment that supports vigorous and resilient forests throughout our rural and urban communities across the state.
