## Summary

In December 2015 the updated *'Wood Supply Chain Component Cost Analysis; A Comparison of WI and U.S. Regional Cost'* project was completed. The updated results reflect data for two years; 7/1/2013 –6/30/2015. The report can be found on the WFPS website at <http://study.wisconsinforestry.org>


Five additional scenarios will be modeled to project the potential impacts on wood availability as part of the *'Wisconsin Wood Supply Assessment'*. The scenario descriptions are as follows:

- Increase level of parcelization.
- Harvesting restrictions due to the presence of wood turtle habitat.
- Oak wilt harvest restrictions – current oak wilt counties.
- Oak wilt harvest restrictions – expanded oak wilt counties.
- Impact of road and bridge weight restrictions.
- Impact on wood markets of a new wood-using facility in Wisconsin.

These additional scenarios will extend the final project report to the end of May 2016.

*'Single Tree Selection Order-of-Removal in Procedures in Northern Hardwood Forests and Rotation Lengths in Red Pine and Aspen Forests'* awarded to Steigerwaldt Land Services, Inc. has been extended to be completed in February 2016.



## In-Kind Hours and Value

Since the Study began, organizations and individuals have reported 321 hours of in-kind service valued at \$16,400 through 2015. This is a conservative number as all organizations and individuals have not all reported their in-kind service hours.

## WFPS Project Results to Policy Recommendations
