9:20 AM Chair Update 10 min	<ul style="list-style-type: none"> Chair Hittle reviews Operational Guidelines Budget paper and Forest Health position paper have been shared with the Governor's office Matt and Tom are working to get new legislators checked in and up to speed on Council Wisconsin Green Fire Webinar took place last month. Council members Tom Hittle, Dr. Adena Rissman participated as panelists. There were over 200 participants. https://wigreenfire.org/wisconsin-forests-at-risk-webinar/ The Council's executive committee has begun work on the 2023-2024 Biennial Report, due June 1st to the Governor's office. Hittle outlines changes to the report content and format to streamline process and increase usability. Hittle solicited location input for March and May council meetings. Ideas brought forward included Kemp Research Station and College of Menominee Nation; request for council members to continue to share any ideas they have.

The Paper Council and GLTPA are working together to develop a fact sheet to provide information so that informed decisions about contracts can be made. Reasonably optimistic that a budget will be produced on schedule.
<p>10:15 AM State Forester Updates National Forest Updates 20 min</p>	<ul style="list-style-type: none"> ● National Forester Updates (Jenn Youngblood): <ul style="list-style-type: none"> ○ All USFS leadership changed January 20th, freeze on everything, much remains unknown ○ Brooke Rollins named nominee for Secretary of Agriculture on Jan 23rd ○ From Chequamegon-Nicolet perspective, we know we should be able to continue timber sales as planned, while there may be a slight dip. ○ Chequamegon-Nicolet employees are trying to continue management and have been putting fire on the ground during the past few weeks. ○ Jenn is leaving Chequamegon-Nicolet to take a position in Alaska, last day is February 20th ○ USFS/CNNF is supporting California wildfires. ● State Forester Updates (Carmen Hardin): <ul style="list-style-type: none"> ○ New DNR Secretary Dr. Karen Hyun started this week, working to add her to agenda to meet with the Council at an upcoming meeting ○ Elle Soderberg hired as new FP specialist. Brian Cole will be starting in mid-February as the second new FP specialist, so the Forest Products Team will be fully staffed. He is coming from ME and will be working out of Green Bay. ○ Recruitment: Silviculturist, Trillion Trees Program Coordinator, and Forest Health Specialist (2 positions) in various stages of recruitment. They are in various stages of interviews.

	<ul style="list-style-type: none"> ○ Kirsten Held, Communications and Outreach Specialist, retired earlier in the month after 34-year career. Division has plans in place for managing this vacancy. ○ National Old-Growth Amendment – Division participated as a Cooperating Agency in the NOGA review process, Greg Edge provided comments on the proposed amendment. 1/7/2025 the Agency decided to withdraw the notice of intent to prepare and environmental impact statement and will not be publishing a final statement. ○ TPO: The WI DNR Forest Products Specialists will be starting soon to conduct the USFS Timber Product Output Survey for 2024 wood consumption with primary forest products mills across the state. This year DNR is taking back administration from USFS. Hoping to give more up to date numbers routinely ○ New class hire of foresters will be posted for recruitment mid to late February. Division hopes to have them on by early June ○ Working to put together 10-person crew to go to Southern California for fire assistance, this ask may change with recent rains. ○ 2025 fire season shaping up to be a long one. 29 fires already over this year to date. Over 50 acres burned. ○ 5-year, \$3 million grant intended for landowner payments through WFLGP, existing eligibility and program requirements are in place. 1/1/2025-12/31/2029 grant timeline. Intended to award the \$3 million in grants over the next 3 years since landowners have 2 years to complete their practice once they receive their award letter in WFLGP. Landowner payments occur at the time of practice completion. Communication and outreach intended to happen within next year to inform landowners, partners, and Cooperating Foresters who may not otherwise be aware of this opportunity. Subset of eligible WFLGP practices are available for IRA funding, tied directly to climate and forest resilience. Covers all of the most common practices (invasive species control, tree planting, etc.) <ul style="list-style-type: none"> ▪ Federal funding for certain grants has been paused. Don't know yet what means for forestry funding. ○ Incorporating much appreciated feedback on Dispute Resolution Process for MFL from November meeting. Council will be informed when it goes to public commenting. DNR is working on the following adjustments: <ul style="list-style-type: none"> ▪ Making sure that landowner roles and expectations are clear ▪ Providing more guidance on when consultants are involved ▪ Providing clarity on who pays for consultants ○ 100-year anniversary for Northern Highland American Legion State Forest <ul style="list-style-type: none"> ▪ Interest in programming to celebrate this

(see Meeting Materials) • Discussion on perspectives regarding seedling supply and site prep issues. Including BCPL ability to use funding for site prep purposes and DNRs current seedling stock. • SAF is considering making red pine a topic and their fall meeting. • Minnesota million initiative referenced regarding restoration of marginal crop land, limitations on how this could be applied in WI due to statutory limitations of how state seedling stock can be utilized. • Call to Council: we need enough interest and need to push this forward. Send interested contacts to Rebecca. Council can make recommendations from there. Any interested council members can join the working group.

11:40 AM State Harvest Volumes: Council Report <i>Action Item: Approve Council Report</i> 15 min	<ul style="list-style-type: none"> Council is statutorily required to submit a report to the Governor if the State reports harvesting under 90% or over 110% of their timber goal This last year DNR’s goal was 33,664 acres of harvest. Recon was done on 38,000 acres for the final 29,929 acre harvest (88.9% on harvest goal) Council members note that it would be useful to see a trend/trajectory to accompany this in the future; DNR noted that trends were shared at the January 2024 Council Meeting (https://councilonforestry.wi.gov/Meetings/StateLandsTimberSalesandTrendsPresentation.pdf) <ul style="list-style-type: none"> Note that the Council’s Industry Strategic Plan and Roadmap will look at fiber availability into the future After discussion, Tom Hittle put forth for consideration the drafted council report titled “State Lands 2023 – 2024 Biennial Harvest Reporting” to be sent to the governor, to the department, and to the appropriate standing committees of the legislature. <ul style="list-style-type: none"> Motion: [Jordan Skiff] moved to approve the drafted report to be sent to the required bodies.
