State Forester Updates Vacancies: FEE Section Chief, Forest Products Specialist, FH Pest Coordinator New Certification Coordinator; Scott Lyon new Forest Products Team Leader Will be launching Forester hire in February. FWP division has new reporting requirement to identify priority habitat work on managed lands. Planning/reporting tied to budget cycle. FH is expecting banner year for spongy moth because of prime conditions previous season. Seedling sales from nursery this year are highest in last 10 years. Still working to get red pine and jack pine seed quantities. Urban Forestry Grant Rule Process finalizing. Applications open around end of Feb, due by June. Started 25-27 budget process; good time for council to engage with the SO is April to August 2024. Will be challenged in upcoming years on workload in tax law due to enrollments in 1999-2001 time range. Will be looking at some enhancements/modifications in dispute resolution process, as had first one since DRP establishment. National Forest Updates Were able to fill 20 entry level marking positions across CNNF. Still have 20 vacancies. Will likely be adding 260mmbf to volume (some in NEPA process). As of last week, have sold 30mmbf this year.
