Goals:

Provide technical assistance and oversight to Wisconsin Forest Practices Study (WFPS) on behalf of the COF. Serve as liason between the WFPS and COF. Assist COF in interpreting WFPS results and in developing recommendations based on those results.

Decision-making Process:

For the purpose of this Committee Consensus will be defined as an acceptable resolution, one that can be supported, even if not the preferred or first choice of each team member.

Issues to be addressed:

WFPS Requests for Proposals (RFPs); review of proposals submitted in response to RFPs; review and interpretation of WFPS products.


Expected Outcomes:
